


0915-1000	Scenario #2	Standard Home Contact – POs to conduct a home visit on a compliant defendant. <ul style="list-style-type: none"> • 2 POs • 1 Role Payer • Search of person and/or room if possible 	Defendant is compliant Pocket knife or pipe in plain view (on a table or couch) or something on the defendant that can be found if a search of the person is done

Contraband on the defendant.</p>
1100-1200	Scenario #4	<p>Unit Compliance Day – POs to conduct a home visit and search of a non-compliant probationer’s residence.</p> <ul style="list-style-type: none"> • 6 – 8 POs • 2 – 3 Role Players (at least one on probation) • Search of person(s) and room(s) 	<p>Contraband in the residence and on the defendant(s)</p>
